Moot Court Proposition Moot Problem

The Union of Tianzhu was a prosperous Country in Asia having a rich culture, legacy and civilization dating back to thousands of years. The Citizens of Tianzhu respected women from time immemorial. The Republic Party of Tianzhu came to power in the Union. The Republic Party of Tianzhu, prior to the election impressed on the masses to vote for them with a manifesto that Women entrepreneurs would be given grant/s and loans with minimal levy of interest with due encouragement of a single window system titled as "Tianzhu Women Leader-2021".

Sangamitra, who became a leading entrepreneur after pursuing her Master in Business Administration and Law in reputed Universities proposed to avail the said scheme floated by the Union of Tianzhu in terms of its promises to Women of Tianzhu in relation to "Tianzhu Women Leader-2021". The main attribute of the said scheme was grant of Rs.1,00,00,000-/-to deserving businesswomen. Sangamitra who was engaged in the business of ethnic clothes having Pan-Tianzhu presence proposed to reach out to the World with her brand "Sangi".

Sangamitra meticulously submitted all paperwork to the competent authority to seek a grant. The competent authority sanctioned the grant in terms of its policies and procedures.

It dawned on the Republic Party of Tianzhu that in order to keep up with its election manifesto's promise in relation to "Tianzhu Women Leader-2021," it needed thousands of crores. To sustain the same which was a burden on the exchequer as well as causing embargo on the development of the Union of Tianzhu, the said Union sought for grant from the World Bank.

Meanwhile, post-dated cheques were given to various applicants who had been granted aids including Sangamitra, being confident that the said cheques would be honored on the due dates sought to purchase various linens, etc., on credit running to lakhs of rupees with a fond hope that she would be able to make good the payments based on the cheques in relation to "Tianzhu Women Leader-2021" scheme by purchasing the said goods from Ms. Devapriya.

Sangamitra tendered a post-dated cheque to Ms. Devapriya for the purpose of discharge of the payments in relation to purchase of goods amounting to Rs.50,00,000-/. The Union of Tianzhu was unable to keep its promise of grants, various negotiable instruments given to grantees including Sangamitra were not honored due to "Insufficient Funds" as aid at the hands of World Bank failed to materialize.

Meanwhile, the cheque given by Sangamitra to Ms. Devapriya was also not honored due to "Insufficient Funds" in Sangamitra's account. Independent of the said grant, Sangamitra also had corpus and funds to sustain her business. Well in time prior to tendering the cheques unto Ms. Devapriya, Sangamitra proposed to deposit Rs.75,00,000-/- into fixed deposit in her name and conduct her business in terms of the grant only.

Albeit, the business of Ms. Devapriya suffered losses as Vendors were not paid and insolvency proceedings were filed, the business of Devapriya was closed in order to pay all the Vendors.

Ms. Devapriya being lost and frustrated filed complaint in terms of section 138 of the Negotiable Instruments (NI) Act, 1881 and another under the auspices of sections 406 and 420 of the Penal Code, 1860.

After due trial as per the Due Process of Law and procedure established by law, Sangamitra was convicted under section 138 NI Act, 1881 and was ordered to pay Rs.75,00,000-/- in terms of the said law including compensation and in default to undergo imprisonment for two years. Sangamitra failed to comply with the said order and underwent imprisonment for two years.

Upon her release, the trial in so far as sections 406 and 420 of the Penal Code, 1860 after due participation of Sangamitra concluded, the Jurisdictional Court taking into consideration amongst others including the earlier conviction of Sangamitra and other facts, found Sangamitra guilty of contravention of sections 406 and 420 of the Penal Code, 1860. She was convicted accordingly and ordered to undergo imprisonment for seven years. Both the Court Proceedings were conducted as per Due Process of Law and Procedure established by law.

Sangamitra aggrieved by the said order of conviction in the case of sections 406 and 420 of the Penal Code, 1860 preferred a Writ Petition to the High Court of Siliconnagara pressing that the order of conviction under the Penal Code 1860 was "Double Jeopardy", and the entire judicial proceedings was not sustainable as the basic tenets of Law privy to Double Jeopardy had been violated. The said matter was argued by Sangamitra as she was well qualified in law.

The High Court of Siliconnagara, after a marathon of arguments, came to the conclusion that the conviction of Sangamitra didn't satisfy the subjective and objective preamble to come under "Double Jeopardy". The applicable laws independent of the Constitution of Tianzhu were also appreciated, the order of conviction was upheld.

Sangamitra aggrieved by the said orders, preferred a Special Leave Petition to the Supreme Court of Tianzhu seeking for Justice highlighting that she was a victim of circumstances after espousing the material facts for dishonor of the Negotiable Instrument, the conviction was based on order in sec 138 NI proceedings, the evidence of the earlier proceedings was considered by the Trial Court and order of conviction was passed in violation of Article 20 of the Constitution of Tianzhu. **"Non bis in idem"** and various other legal enactments applicable to Union of Tianzhu were part of the Petition.

Hon'ble Supreme Court of Tianzhu, appreciating in the protem applicability and operation of Article 20 of the Constitution of Tianzhu, and various other legal enactments applicable, granted leave and admitted the matter and granted protem stay on the order of conviction with consequential orders to meet ends of Justice.

At the time of filing the said Special Leave Petition, Sangamitra had also filed a Writ Petition under Article 32 of the Constitution of Tianzhu for violation of Articles 14 and 20 of the Constitution of Tianzhu and also claiming damages and compensation in relation to vexation due to "Tianzhu Women Leader-2021" and in relation to her order of conviction, sought consequential relief against the Union of Tianzhu. The Hon'ble Supreme Court of Tianzhu admitted the same and has issued notice to the Union of Tianzhu and other necessary parties including Ms. Devapriya.

Both the matters are set-out for final arguments before the Hon'ble Supreme Court of Tianzhu.

NOTE:

The participants may, at their discretion, frame up to two or more issues.

The Laws applicable to Union of Tianzhu shall be construed to be laws applicable in the Union of India i.e. Bharat.

Moot Problem has been drafted by Dr. M. Sunil Sastry, LL.M, M.Phil., PhD., Advocate, High Court of Karnataka and Guest Faculty in Law. We kindly request that participants refrain from attempting to contact Dr. M. Sunil Sastry in any manner about the moot problem, as this will lead to immediate disqualification from the competition.

Rules and Regulations.

Eligibility:

- Students duly enrolled and pursuing full-time 5 years or 3 years Degree Course may apply to participate in the given Competition.
- Students from any University / Department / Institute recognized by the Bar Council of India, to impart legal education are eligible to participate.

Team Composition:

- A team will consist of three (3) members.
- A team of three members will include two speakers and one researcher.
- All members of a team should belong to the same institution.
- Any team, intending to change the team composition of the team shall intimate the Organizing Committee by sending an e-mail at **mootcourt.rvils@rvei.edu.in** by **21**st **February**, **2024**.
- Any person, other than the registered team members, is not eligible to avail facilities reserved for the student participants.

Structure of the Competition:

The competition will be held for three days, from 1st to 3rd March 2024.

1 st March 2024	Inaugural Programme Desk Registration Researchers' Test and Draw of Lots for Preliminary Rounds
2 nd March 2024	Preliminary Rounds I and II Quarter Final Rounds
3 rd March 2024	Semi Final Rounds Final Round Valedictory Programme

Language:

All oral and written submissions are required to be made in English only, which shall be the official language of the competition.

Dress Code:

- The participants shall adhere to the following dress code while in the courtrooms:
- Ladies White salwar and kurta or white shirt and black trousers along with a black blazer and black shoes.
- Gentlemen White shirt, black trousers, a black blazer and black shoes.

Registration:

- There will be a Team cap of 24 teams and these 24 teams shall be allowed to register on a first come first serve basis.
- The registration fee for the competition is **INR 3,835/-** and **Rs.5,835/-** including accommodation per team (including 18% GST).

Provisional Registration:

- · Provisional Registration shall be made by filling up the Google form given below
- The last date for Provisional Registration is 5th January, 2024.
- The official acknowledgement of the selected colleges shall be sent by mail by 8th January, 2024.

Final Registration:

- On confirmation of the teams, the Registration form along with Payment receipt need to be scanned and sent to mootcourt.rvils@rvei.edu.in with the subject 'Registration for 2nd All India Moot Court Competition, 2024'.

- Teams will be assigned a team code after registration. All communication thereinafter will be through the team codes.

Travel and Accommodation:

- Travel and Accommodation forms shall be sent via mail once the team codes are allotted.
- Accommodation shall be provided from 1st March afternoon to 3rd March morning.
- Teams willing to stay beyond the dates of the moot, as specified will have to bear the extra charges.
- The interested students are required, to inform the Organizing Committee, through their Travel and Accommodation Form, to enable them to make necessary arrangements. Under no circumstances the Organizer shall provide accommodation to any other person accompanying the team.
- Teams should send their travel and accommodation plans by 21st January, 2024.

Clarification:

- Clarifications can be sought on any part of the moot proposition and must be clear. These clarifications are to be sent via e-mail at **mootcourt.rvils@rvei.edu.in**
- It is at the discretion of the Organizing Committee to decide whether a clarification sought for is valid and is to be clarified.
- The clarification e-mails are to be sent on or before 25th January, 2024.

Memorial:

- Each team shall research into the domain of the moot problem and prepare memorial for both sides, namely, petitioner and respondent.
- Soft copies of the memorials must be submitted to mootcourt.rvils@rvei.edu.in by 11th February, 2024, with the subject of the email as "Memorial Submission- (Team Code)". The memorial files should be in pdf formats with the file names as 'Team code- Petitioner/Respondent.' For e.g.: RVILS P01, RVILS R01.
- The memorial scores will contribute to decide the selection of the teams for the Oral Rounds in case of time.

Format of Memorial:

- The memorials are to be submitted in the format prescribed. If a team fails to comply with the given format, it may be penalized in the form of deductions from the memorial marks.
- The memorials shall contain all of, and only, the following heads, namely :
 - a) Cover Page f) Statement of Facts
 - b) Table of Contents
 - c) List of Abbreviations
 - d) Index of Authorities
 - e) Statement of Jurisdiction

- j) Prayer
- Cover Page shall include the team code on upper corner, name of the case, parties for whom written submissions are made, name of the forum approached for dispute resolution and year. Cover page of the memorial on behalf of petitioner shall be in **Blue**, and respondent shall be in **Red**.
- FORMATTING AND CITATIONS: All teams shall give footnotes by adhering to Blue Book: A Uniform System of Citations (20th Edition).
 - The Memorials shall be typed on A4 size paper having a one-inch margin on all sides.
 - The font shall be **Times New Roman**; font size is 12 and line spacing shall be 1.5. For footnotes, the font size shall be 10 with a line spacing of 1.0.
 - Page numbering shall be at the bottom of each page.
- Statements of Facts must not exceed two (2) pages. Further, Arguments Advanced must not exceed twenty-five (25) pages and the total number of pages of the memorials must not exceed thirty-five (35). Exceeding the limit, the memorial shall attract negative marking of one (1) point each for every additional page.
- Compendium or any other references are optional. Only one Compendium to be submitted from each side. The Compendium must be submitted in PDF format.
- Once the written submissions have been submitted, no revisions, supplements, or additions will be allowed.
- Eight hard copies (4 copies of each side) via courier to be sent by 17th February, 2024.
- Submissions made after the specified deadline may lead to penalties in the form of deductions from the memorial marks.

Exchange of Memorial:

- Exchange of memorials will take place on 1st March, 2024 for preliminary rounds. The exchange of memorials for other rounds will be done immediately after the declaration of results.
- Teams are strictly forbidden from making any annotations or causing any damage to the exchanged Memorials.
- Teams are also prohibited from reproducing photocopies of such Memorials.
- The Memorial of the opposing team must be returned to the Court officers upon the completion of each Round.

Assessment of Memorials:

The memorials shall be assessed out of 100 marks, by a team of experts on the predetermined criterion, as specified here under.

Researchers' Test:

- Researchers' Test will be conducted on 1st March, 2024.
- The Researcher's Test will be conducted in offline mode.
- Only the Researcher is supposed to give the test.
- The test will consist of questions relating to the Problem, both legal and factual. The test will be of One Hour and will comprise a total of 50 MCQs of 100 marks.
- In case if any tie subsists, the memorial score shall serve as tie-breaker.

Oral Rounds:

Preliminary Round:

- All Teams shall participate in the preliminary rounds.
- The rounds shall be conducted physically in various courtrooms in two phases, Preliminary Round I and Preliminary Round II.
- Each Team shall argue once from each side allotted to them through Draw of Lots which shall be notified to the teams shortly after the Opening Ceremony. The Memorials of opposing teams will be made available to both the teams and judges before the rounds accordingly.
- In both the rounds, each team will be given 25 minutes to present their oral pleadings and an additional 5 minutes shall be given for Rebuttal and Surrebuttal.
- Teams which has scored the highest from both the Preliminary Rounds shall be qualified for the Quarter Final Round.
- In case of a tie between two teams, Memorial Scores shall be considered.

Quarter-Final Rounds:

- Eight teams from the Preliminary Rounds shall qualify for the Quarter-Final Rounds.
- A Draw of Lots shall be conducted to determine the pleading side for the Quarter-Final Rounds.
- The Quarter-Final Rounds shall be Knock-Out Rounds.
- Only Oral Rounds Scores shall be considered for evaluation.
- In case of a Tie, the team with the higher score in the Memorials shall proceed to the Semi-Final Rounds.
- Each team will get 35 minutes to argue from the allotted side, and additional 5 minutes for Rebuttal and Surrebuttal.

Semi-Final Rounds:

- 4 teams from the Quarter-Final Rounds shall qualify for the Semi-Final Rounds.
- A Draw of Lots shall be conducted to determine the pleading side for the Semi-Final Rounds.
- The Semi Final Rounds shall be Knock-Out Rounds.
- Only Oral Rounds Scores shall be considered for evaluation.
- In case of a Tie, the team with the higher score in the Memorials shall proceed to the Final Rounds.
- Each team will get 40 minutes to argue from the allotted side, and additional 5 minutes for Rebuttal and Surrebuttal.

Final Round:

- Two teams from the Semi-Final Round shall qualify for the Final round.
- A Draw of Lots shall be conducted to determine the pleading side for the Final Round.
- Each team will get a minimum of 45 minutes to argue, with an additional 5 minutes for Rebuttal and Sur-rebuttal each.
- In case of a tie, memorials marks will be considered.

Assessment Criterion for Oral Pleadings:

Team performance of the orators shall be judged in all rounds on the basis of following criteria:

Knowledge of Facts	20 Marks
Application of Laws to Facts and Interpretation	20 Marks
Argumentative Skills	20 Marks
Clarity of Thought and Expression	20 Marks
Court Mannerisms 10 Marks	
Response to Questions	10 Marks

Anonymity of Teams:

- Teams shall not reveal their identity in any form during the Competition, except by the means of their Team Code allotted by the Organizing Committee.
- Teams must not reveal the name of their institution or names of the participants, anywhere in the memorials or in the course of the oral arguments.
- Teams must also not make use of or display in any manner whatsoever any logo, pins, badges etc. Any material presented to the Panel should be devoid of any identification mark(s)/seal(s) of the Team.

- Any violation of Rules as mentioned above shall attract severe penalty or disqualification as determined by the Organizing Committee.
- The decision of the Organizing Committee in this regard shall be final and binding; not subject to challenge.

Miscellaneous Provisions:

- No team shall indulge themselves in any act of misconduct in or outside of the court room, undermining the credibility of judges or that of the competition. If done, it may lead to immediate disqualification.
- Teams shall not be allowed to observe the oral rounds of another team. Unless they have been officially knocked out of the competition. Scouting is strictly prohibited. Scouting shall entail disqualification.
- Any behaviour of indiscipline with the Organizing Committee or any other staff member or student volunteer shall be dealt with strictly.
- No team shall ask for feedback immediately on completion of any round.
- Any attempt to approach the framer of the moot problem or judges of the competition, prior to the competition shall be met with strict consequences.
- The organizers reserve the right to amend and interpret any rules of procedure during the competition.
