Each human being has exactly the same number of hours and minutes every day. Rich people can't buy more hours, scientists can't invest new minutes and we can't save time to spend it on the other day.

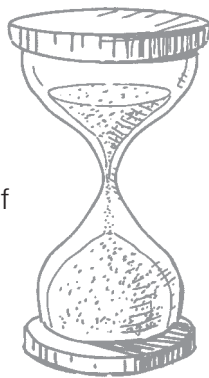
